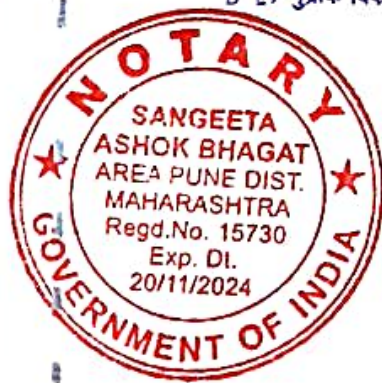

MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding is made and executed on the 28th September 2024.



BETWEEN

Sahyadri Hospitals Private Limited, CIN: U85110PN1996PTC099499 a company incorporated under the Companies Act, 1956, having its registered office at Survey No. 89 & 90, Plot No. 54, Lokmanya Colony, Kothrud, Pune - 411038, Maharashtra hereinafter referred to as "**Sahyadri**" (which expression shall, unless it is repugnant to the context or meaning thereof, be deemed to mean and include its assignees, administrators and executors).

...OF THE ONE PART

AND

St Andrews College of Nursing, Pune, a Nursing training college having its office at N.M.Wadia Hospital Campus, 283 Shukrawar Peth, Pune-411002 Maharashtra hereinafter referred to as "**Institute**" (which expression shall unless it be repugnant to the context or meaning thereof shall be Deemed to mean and include its assignees, administrators and executors).

...OF THE SECOND PART

Parties hereby agree to enter into this Memorandum of Understanding on following terms and conditions:

1. Sahyadri hereby allows the Institute to avail practical experience to its BSc. Nursing students at its various hospitals in Pune (hereinafter referred to as "Hospital").
2. B.Sc. Nursing students will be sent to Hospital for practical experience for the continuous or interspersed period amounting to not less than 3 months and a maximum of 6 months.
3. B.Sc (Nursing) students of various batches may be required to be posted at various branches of the Sahyadri Hospital based on their academic requirements.
4. Sahyadri shall provide meals and accommodation to female nursing Internship students if needed who will be sent by the institute pursuant to this MOU & expenses a per hostel policy. Teachers will accompany students in the clinical field except for internship experience.
5. It is hereby agreed by the Institute that there shall be no employer-employee, master- servant, principal-agent, institute-student or any other similar relationship between Sahyadri/Hospital and students. Entire responsibility of the students shall be with the Institute and Sahyadri/Hospital shall not bear any liability of their conduct, performance or engagement.
6. Institute will ensure that the students will maintain discipline during the tenure of training in the Hospital. Students shall abide by all rules, regulations and policies set by the Hospital_Institute shall bear the responsibility of any unlawful and

- undisciplined behaviour or acts and omissions on the part of the students.
7. Both the Parties have accepted that Institute to maintain the attendance of the students who will be sent to Sahyadri Hospital. Institute shall ensure that the student nurses shall attend the Hospital regularly and in time for the duty hours. The clinical rotation of the students will be planned in coordination with the Institute academic requirements and Hospital policy and protocols.
 8. Sahyadri shall provide a certificate of completion after successfully completing their practical internship experience tenure. In case of any gross misconduct, the certificate of completion shall not be awarded and the student may be asked to quit the internship, basis Sahyadri management decision.
 9. Practical examinations of the college and university will be conducted based on Sahyadri policy and protocols.
 10. The authorities appointed by the government for the purpose of inspecting the clinical specialties for nursing programs are as under:
 - a. Indian Nursing Council
 - b. Maharashtra Nursing Council
 - c. State Government and
 - d. Maharashtra University of Health Sciences Nashik (MUHS)These authorities shall inspect the clinical areas per the statutory body norms and the Hospital shall cooperate with necessary documents.
 11. Institute, it's students must maintain must always keep highest level of secrecy and confidentiality of data, records, documents and any such other information relating to this MoU and business of Sahyadri or any of its clients which may be known to them, or confided in them, by any means, or which they become aware of during the normal course of working in the course of their association with Sahyadri under this MoU. Institute shall take all reasonable steps and necessary precautions to ensure that the confidentiality of materials and information is preserved and also agrees that it shall not make any disclosure to any third party including public announcement or media disclosure without prior written approval of Sahyadri. Institute agrees that the provisions of this clause shall survive the expiration or earlier termination of this MoU.
 12. All intellectual property including but not limited to trademark, logo, slogans, marks, labels whether registered or not, shall be the sole property of Party having its ownership and neither Party shall be authorized by virtue of anything contained in this MoU to use or exploit in any manner whatsoever any intellectual property owned by the other Party, except as may be mutually agreed between the Parties for the purposes of this MoU..
 13. The Memorandum of Understanding is valid for a period of **THREE YEARS (23rd September 2024 to 22nd September 2027)** i.e. from the date of this



Memorandum of Understanding till 22nd September 2027 and renewable in writing on mutually agreed terms and conditions.

14. It is agreed by and between the Parties that in case of any dispute arising in terms of this Memorandum of Understanding, the Medical Director, Sahyadri Hospitals Private Limited and the Chairman, St Andrews College of Nursing, Pune equally will have the authority to terminate this Memorandum of Understanding without any prior notice.
15. It is specifically agreed between the Parties that no consideration shall be payable by either Party to the other pursuant to this MOU. Institute hereby acknowledges that Sahyadri has signed in this MOU on pro-bono basis and from the sense of participating in noble cause to serve the mankind. Hence, Sahyadri and the Hospital shall bear no liability whatsoever arising from this MOU.
16. Hence the parties have signed this Memorandum of Understanding on the day and year mentioned above.
17. The MoU cannot be assigned or transferred in whole or in part by Institute without Sahyadri's express written prior consent. Sahyadri can freely assign or transfer the MoU including to (i) any company of its group or any business affiliate of Sahyadri, (ii) to any other person on the occasion of a merger or a total or partial assignment of Sahyadri's assets or business. Institute consents ~~is agreed to such transfers and undertakes to provide to Sahyadri without delay any reiteration of its approval that Sahyadri may request.~~
18. If any provision of this MoU is or becomes invalid or unenforceable in law for any reason, it will only be ineffective to the extent of the invalidity or unenforceability and no other provision of this MoU shall be affected or rendered invalid or unenforceable for such reason. To the extent practicable, any invalid or unenforceable provision shall be replaced by a valid and enforceable provision agreed to by the Parties and having the same effect on the Parties as was intended by such invalid or unenforceable provision.
19. This MoU together with any documents referred to in this MoU, if any, contain the entire MoU between the Parties with respect to the subject matter of this MoU and supersedes all prior understandings, MoU and correspondences.
20. At no time and in no way and for no reason whatsoever will one of the Parties be considered an agent or employee of the other and no Party will have the authority or the power to create binding obligations on the other Party or to contract in its name or to create any obligation for which it is responsible, in whatever manner and for whatever reason.
21. The Parties must not violate any applicable Anti-Bribery and Anti-corruption Laws. Both the Parties must implement adequate procedures designed to prevent it or its staff from engaging in any activity which would constitute an offence under any applicable Anti-Bribery and Anti-corruption Laws.
22. Failure by any of Party to enforce at any time or for any period any one or more of



the terms or conditions of this MoU, shall not be a waiver of them or of the right at any time subsequently to enforce all terms and conditions of this MoU.

23. The college should give our organization first priority for campus interviews.

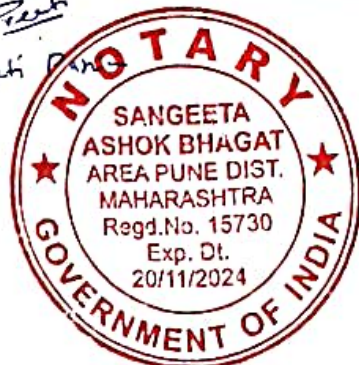

This is memorandum of understanding, hereinafter called as MOU, for association of St. Andrews College of Nursing, through its Principal having President Mr. Kadwin K Pillai having its office at N.M.Wadia Hospital Campus, 283, Shukrawar Peth, Pune-411 002, Maharashtra, here after called as a of the part with Chaitanya Institute for Mental Health, Director Mr Rony George at its office at, Bhagat Puram, Khadi Machine Chowk, Katraj-Kondhwa Road, Pune- 411048.

Whereas "St. Andrews College of Nursing," is conducting Basic B.Sc Nursing, B.Sc Nursing, Post Basic B.Sc Nursing and M.Sc Nursing course in the affiliation with Maharashtra University of Health Sciences, Nashik, Indian Nursing Council, New Delhi, Government of Maharashtra, Mumbai and Maharashtra Nursing Council, Mumbai.

Whereas Nursing students of the said nursing educational institution are required to take specialized training and learning experiences in clinical nursing embracing all the specialities and the branches including training in Mental Health Nursing during their 4 years and 2 years nursing courses.(i.e Basic B.Sc, B.Sc Nursing, Post Basic B.Sc and M.Sc Nursing) educational programme.

And whereas the said "St. Andrews College of Nursing," has approached the party of the second part to allow the students to gain clinical nursing training in Basic BSc, B.Sc, Post Basic B.Sc and M.Sc Nursing students.

And whereas the party of the second part is, "The Hospital"/ The Trust, established under the Bombay Public charitable Trust Act and the trust runs and maintains "The Hospital in the name of Chaitanya Institute for Mental Health. The Hospital having the capacity of 200 beds and having all the required infrastructure required for imparting training to the students of Basic B.Sc, B.Sc, Post Basic B.Sc and M.Sc Nursing students.

And whereas the offer of "St. Andrews College of Nursing," has been accepted by the "Chaitanya Institute for Mental Health" under certain terms and conditions which are mutually understood and agreed between the parties and which the parties here to desire to put into writing.

Therefore, this MOU witnessed as under...

1. This MOU is executed on this 1st December 2024, initially for the period of 3 years from the date of commencement, which may be extended on mutual consent and agreement.
2. The parties of the first part i.e. "St. Andrews College of Nursing," shall send its Basic B.Sc, B.Sc, Post Basic B.Sc and M.Sc Nursing students for the purpose of training and experience to the hospital of the second part.
3. All batch wise students to be posted for clinical experience.
4. The total number of students placed will be divided in to 4 batches and the number may increase in the succeeding years.
5. Clinical areas are as follows,
 - Psychiatric Wards
 - Acute Care Ward Male and Female.
 - De-Addiction Unit.
 - Geriatric Care Unit Male and Female.
 - Rehabilitation Unit.
6. All the students in every ward would be accompanied by their supervisors for guiding, Teaching and demonstrating nursing procedures to the students.
7. No students will leave in any ward or department without being supervised by the supervisor appointed for that purpose by "St. Andrews College of Nursing."
8. Rotation of students will be planned in consultation with the Nursing service Department of "The Hospital" i.e. the Administrator/co-ordinator of "The Hospital"
9. Inspection: The authorities appointed by the authority for the purpose of inspecting the clinical specialities for Basic B.Sc, B.Sc, Post Basic B.B.Sc Nursing Programme as under.
 - Maharashtra Nursing, Council, Mumbai
 - Indian Nursing Council, New Delhi
 - Government Of Maharashtra, Mumbai (DMER/MEDD)
 - Maharashtra University of Health Sciences (MUHS), Nashik.
10. The demographic and infrastructural data of the "The Hospital is required to be furnished at the time of inspection.





11. Assistance from the Hospitals Nursing, Medical and paramedical personnel shall assists the students of the, "St. Andrews College of Nursing" in clinical teaching as and when found necessary and shall guide the college students and staff in hospital policies and routines.
12. The hospital shall not be responsible for any act of negligence of any of the students of the "St. Andrews College of Nursing."
13. Consideration for the purpose of making, The Hospital' available for training to the students and providing the clinical facility to the students of "The St. Andrews College of Nursing," is hereby understood between the parties that they shall compensate the Hospital and pay a consideration of an amount of Rs. 100/- per day per student during their clinical experience. That may be revised in between.
14. In case of any dispute the parties, the same will be subject to jurisdiction of Pune court.

This is memorandum of understanding, herein after call as MOU for association of St. Andrews education foundation St. Andrews College of Nursing, Pune here after called as the foundation of the part with **Pune Adventist Hospital**, Salisbury Park, Post Box 1405, Market Yard, Gultekadi, Pune Maharashtra -411037

Whereas the foundation was established in 2006 duly recognized by Indian Nursing Council, New Delhi, Maharashtra Nursing Council, Mumbai, and affiliated to Maharashtra University of health Sciences, Nashik and approved by Government of Maharashtra Vide G.R No. NUR/1306/CR-82/06/EDU-1; Dated 31/01.2006 and Trustee Mr.KedwinK.Pillai

Whereas the foundation conducts nursing courses

Where as the party of the first part has willing to start

One of the members of the party of second part shall coordinate activity of the training of students of the St. Andrews College of Nursing. The party of the second part has agreed to give the cooperation to the party of the first part for providing clinical training to the students regularly under certain terms and conditions which have been mutually agreed by and between the parties. As per the MOU the party of the second part shall provide clinical (Hospital) training to the students from the St. Andrews College of Nursing Pune for a period of Five (5) years and the party of the first part shall send the students for the purpose of training and experience of the hospital of the party of second part. The party of the second part here by assures to provide the said training to B. Sc. Nursing, P.B.B. Sc. Nursing, M.Sc. Nursing Course without any interruption.

Students to be placed or clinical experience

Nursing students will be sent from the time period 2023 and it will be continued till 5 Years

Hours of placement in the clinical areas

The nursing students will be posted as per curriculum prescribed by Indian Nursing council, MUHS Nashik except during holidays, vacation and examination and for institutional activities.

Clinical Areas

The students of the nursing course shall be receiving training in Medical, Surgical and Orthopedic wards, OT, CATH Lab, ICU, CCU, OPD's of all specialties, Pediatrics(Medical, Surgical, ICU, NICU), Obstetrics and gynecology (Gynaec

OT, labor room, ANC, PNC), oncology, cardiology, endocrinology, nephrology, deficiency and communicable diseases and other specialized units as per INC and MUHS norms.

All the students in every wards and OPDs etc., would be accompanied by their Clinical Tutors on the wards for guiding, teaching and demonstrating nursing procedures to the students. No students will be left in the ward or department without being supervised by the Clinical Tutors appointed for that purpose by the Foundation.


